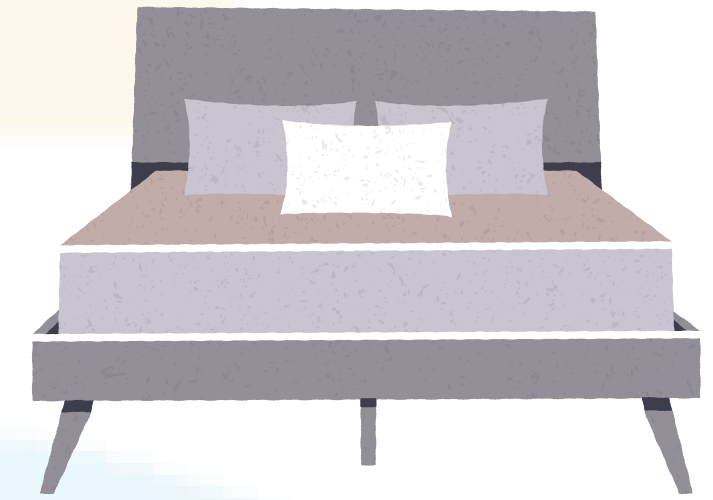


# Town of Greater Napanee Council Highlights

Regular Meeting of Council for June 14, 2022

## Short-Term Accommodation By-law Update

Council has supported Option 3 B provided in the Short-Term Accommodation By-law update. Option 3 entails implementing a short-term accommodation licencing program in Greater Napanee. Option B includes having two flat licensing fees, one where the operator is the primary resident and one where the operator is not. Staff will also work on strengthening the existing by-laws that regulate nuisance activities in the community. Regular updates on this project will continue to be provided to future Council meetings.

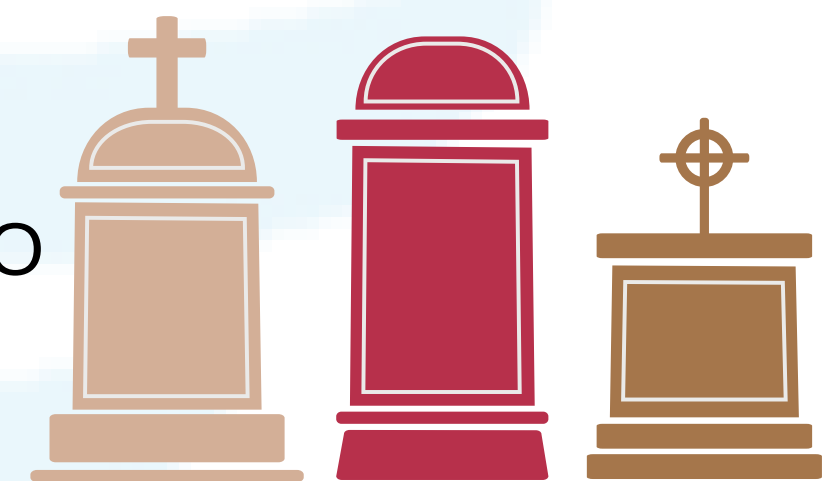


## Tile Drainage Loan Program

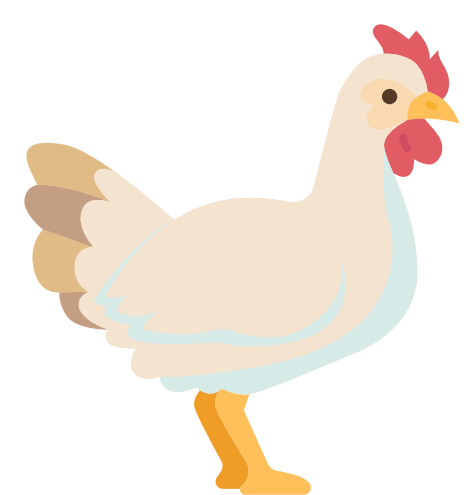
Council has directed staff to accept applications under the Tile Drainage Act in accordance with By-law 2009-0054. Council has appointed Terry Lyman, Public Works Lead Hand, as a Tile Drainage Inspector for the purpose of the Tile Drainage Act. Council has appointed Brian Marrison, Public Works Lead Hand, and Brent Kelly, Property Standards Officer, as alternate Tile Drainage Inspectors. The Tile Loan Program is an OMAFRA program administered by local municipalities.

## Draft By-law to Regulate the Operation of Municipally Owned Cemeteries

Council has endorsed the draft Town By-law to Regulate the Operation of Municipally Owned Cemeteries. Staff will forward the draft by-law to the BAO registrar for approval prior to bringing it back to Council for final approval.



## Upcoming Projects:

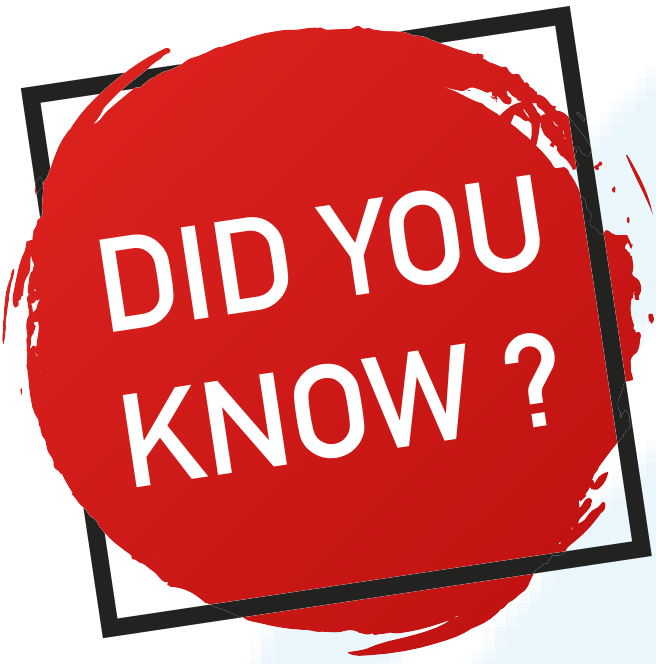

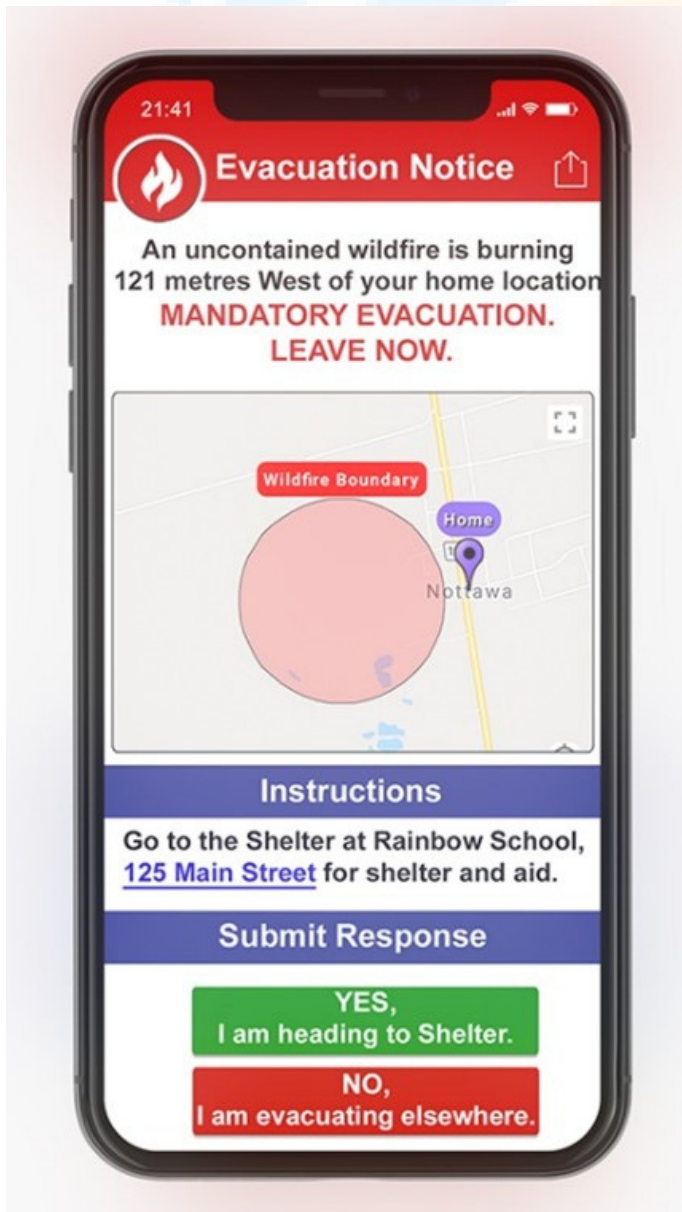

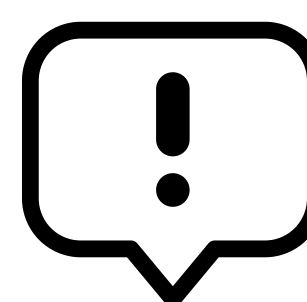
