Regular Meeting of Council for May 28, 2024

2024 Community Risk Assessment - Fire Protection Services

Council received a presentation from the Fire Chief regarding the 2024 Community Risk Assessment (CRA) - Fire Protection Services. Council directed staff to use the 2024 Community Risk Assessment as a foundation to begin the Master Fire Planning process and return a draft Master Fire Plan for Council's consideration by the end of September 2024.



Short Term Accommodations Update

Council directed staff to continue working on a potential short term accommodation licensing by-law. Once a draft by-law has been created, it will be shared for public comments on our engagement page at www.letstalkgreaternapanee.com. In the meantime, Council has directed staff to undertake more public education work on existing by-laws that apply to residential properties. Staff will also be bringing forward a potential by-law amendment to create an administration fee as a cost-recovery measure for repeated by-law violations at the same property.

Little Forest Proposal Update

Council gave formal approval to the Lennox and Addington Stewardship Council to install a little forest on the vacant lot off Marilyn Avenue. Details will be provided as the project moves forward.



South Fredericksburgh Playground Replacement

Council authorized the purchasing of new playground equipment in South Fredericksburgh. Staff were directed to move forward with purchasing playground equipment that includes a 6' Wave Slide, Overhead Ladder, Twin Rider Teeter, and Hex Climber. The total cost for this option is \$22,000.00.

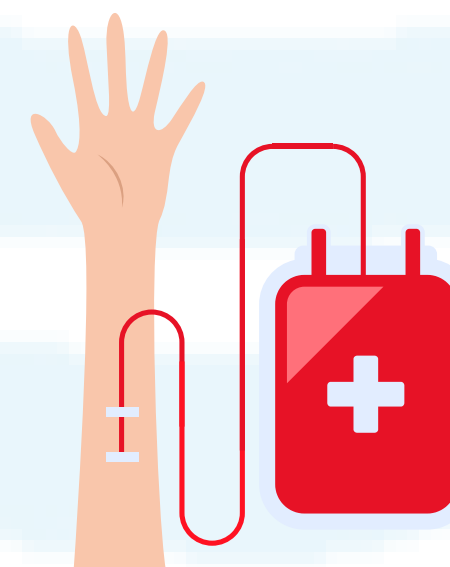
Transit Agreement - Deseronto Transit Pilot Project

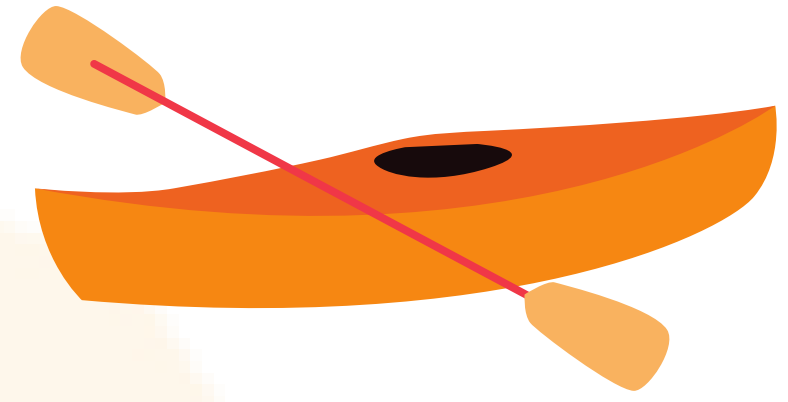
What's Happening in Our Municipal Departments:

Financial Services

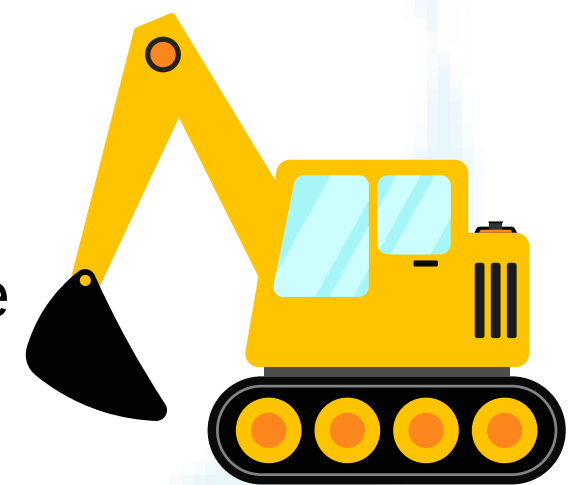

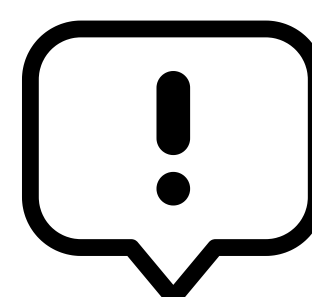
