Regular Meeting of Council for December 10, 2024

Deputation - Community Engagement Committee Proposal

Council heard a <u>deputation</u> regarding a request to create a Community <u>Engagement</u> Committee. The proposed committee would promote participation, collaborate with existing volunteer-run groups and committees, empower grassroots initiatives, foster a culture of care, organize engagement opportunities, and be empowered to seek outside support through grants and corporate sponsorships when appropriate.

Market Square Farmers' Market Partnership

Council received a <u>report</u> on a proposed Market Square Farmers' Market Partnership. Staff were directed to enter into discussions with the Lennox and Addington Chamber of Commerce to develop an operating agreement for a farmers' market in Market Square.

KPMG Forensic Review

Council received a report regarding the KPMG Forensic Review of a 2022 emergency procurement of a trackless sidewalk snow machine as well as a fraud risk assessment related to the Town's Procurement By-law and accompanying processes. Both <u>reports</u> are available on the December 10th agenda.

Advisory Committees By-law


Council received a <u>report</u> to consider the adoption of an Advisory Committee By-law. Council directed staff to present an updated report at the January 14th meeting for further review of the draft Advisory Committee Terms of Reference which incorporates feedback received up to January 6th, 2025, including feedback received during the December 10th meeting.

Town of Greater Napanee Blue Box Transition Report #4: Recycling at Waste Disposal Sites in 2025

Council received a <u>report</u> regarding the Blue Box Transition Report #4: Recycling at Waste Disposal Sites in 2025. Council approved amending Schedule "E" of By-law No. 06-14 to remove the \$5 load fee for blue box materials at the Town's Waste Disposal Sites. An amendment to the by-law will be brought back to Council for passing following the mandatory public notice period as required by the Public Notice Policy By-Law.



Town of Greater Napanee Blue Box Transition Report #5: Blue Box Transition Communications Plan

Council received a <u>report</u> for information on the Town of Greater Napanee Blue Box Transition Report #5 outlining a communications plan. The plan will be used to help guide what information needs to be relayed to each group that is impacted during the transition and how the changes will be communicated.



Funding of the Curbside Collection of Garbage and Recycling in 2025

Council received a <u>report</u> for information on the <u>funding</u> of the curbside collection of garbage and recycling in 2025. Council directed that bag tags continue to be <u>funded</u> through a <u>special tax levy</u> and be <u>mailed</u> out with the tax bills in January for the remainder of this Council's term.

Best and Bash Arena Customer Service Desk Hours of Operation

Council received a <u>report</u> for information on the Customer Service Hours of Operation at the Best & Bash Arena. Staff were directed to change the current hours of operation back to Monday to Friday, from 8:30 am - 4:30 pm. The changes will be effective immediately.

Emergency Response Plan

Council received a <u>report</u> on the Town's Emergency Response Plan. Council supported 2024 compliance activities and adopted the Emergency Response Plan through the passage of the Emergency Response Plan Bylaw as presented within the council agenda.
